 - Chief Kahle continues to be active with the Fiesta de los Bomberos event.
 He is proud to announce that we will provide \$67,000 to support our area firefighters with cancer prevention, cardiac services and mental health services.
 - SAFER Grant. We received our FEMA grant and process is in place to hire by November 18th.
 - PSPRS Reform. The State PSPRS board approved the four recommended changes on September 27th. Unfortunately, we do not know what that impact will be on RVFD. Concurrently, AFDA is working on a new bill that may help fund the increase.
 - Growth Rocking K has officially started its construction.
 - 4 Fire Calls. We had one working house fire that was out of the district.

8. New Business

- **A.** 2020-014 Presentation by the District's Auditor of the District's FY 2018/19 Annual Financial Audit and review discussion and possible action by the Board to officially receive the audit.
 - Jennifer Phillips, CPA attended to present our audited annual financial report for FY 1819. A draft of the report was also provided to the board.

-Motion by Chairperson Harrington, second by Clerk Tate to officially receive the District FY 18/19 Annual Financial Audit. Motion passed 4 to 0.

- **B.** 2020-015 Review, discussion and possible action concerning the Board Member Vacancy.
 - Board Member Terry Newman submitted his resignation at the end of our last regular board meeting. Our bylaws require the board to "within 90 days of the vacancy, appoint a qualified elector to fill the vacancy to serve for the remainder of the term." However, the bylaws do not provide a method of appointment." Likewise, ARS 48-803.B requires the board to fill the vacancy within 90 days. If the board is unable to, the Pima County Board of Supervisors is required to fill the position.

General discussions took place regarding options on how fill the board vacancy. RVFD Attorney Donna Aversa advised the Board that it is in the sole discretion of the Board, as long as there is no secret ballot. She also recommended, based on best practice, to informally seek out interested members of the community by advertising or posting a Notice of Board Vacancy in local publications and request a letter of interest to be submitted by a set deadline. The Board can then consider the applicants at the next regular meeting or schedule a special meeting.

The Board advised Chief Kahle and Staff to place a notice in the Vail Voice and requesting letters of interest to be submitted to Administrative Manager Laura Bucklin by December 2, 2019. Once received, invite interested parties to the November and December Board Meetings. An Executive Session may be held for interviews. Board Members also requested Chief Kahle and Staff to post the notice on other social media websites as well as the Post Office.

Clerk Tate wanted to thank Terry Newman for his service as a Board Member.

-Motion by Clerk Tate, second by Member Spears to accept Terry Newman's resignation per A.R.S. § 38-291 (3). Motion passed unanimously 4 to 0.
