## Resolution No. 23-018

## **APPROVAL OF FISCAL YEAR 2023/2024 BUDGET**

A Formal Resolution of the Governing Board of the Rincon Valley Fire District, to adopt the 2023/2024 Fiscal Year Budget of \$7,209,506.00, and to encumber sufficient funds to cover outstanding items (purchase orders, checks, warrants, etc.). From the previous fiscal year, less any cash and liability reserves, and to encumber any carryover amount to offset taxes (less any unreimbursed stop/loss payments and any adjustments for uncollected out of District fire revenues incurred prior to June 30, 2023). Establishing the balance to be utilized as our fiscal year end Reserved Fund Balance as per the Rincon Valley Fire District Policy.

WHEREAS, Arizona Revised Statutes Title 48 requires the Rincon Valley Fire District to estimate revenue or expense for one fiscal year, adopt an annual budget and determine the compensation payable to District personnel; and

WHEREAS, a Public Hearing was held on the 2023/2024 Fiscal Year Budget on June 14, 2023, in compliance with State Law; and

WHEREAS, the Rincon Valley Fire District wishes to encumber any carryover amount to remain in the General Fund as our fiscal year end. Reserved Fund Balance to be maintained to allow the Rincon Valley Fire District to continue providing services to the community in case of economic downturns and/or unexpected emergencies or requirements. To provide working capital in the first several months of the fiscal year, until sufficient revenues are available to fund operations.

NOW THEREFORE, BE IT RESOLVED, that the Rincon Valley Fire District adopts the 2023/2024 Fiscal Year Budget of \$7,209,506.00, and encumbers sufficient funds to cover outstanding items (purchase orders, Checks, warrants, etc.), and any cash and liability reserves, and any carryover amounts to offset taxes (less any unreimbursed stop/loss payments and any adjustments for uncollected out of District fire revenues incurred prior to June 30, 2023), to remain in the General Fund as the Rincon Valley Fire District fiscal year end Reserved Fund Balance.
