# Item #4 - Review, discussion and possible action regarding the Application for Catastrophic Disability Retirement Benefits and to review the Individual Medical Examiner (IME) report for Benjamin Wooley.

 The Local Pension Board had the opportunity to review the medical records and the report from Dr. Thrasher, the Individual Medical Examiner during Executive Session.

-Motion by Member Brown, second by Member Sharma to accept the Application for Catastrophic Disability for Firefighter Benjamin Wooley, and submit to Public Safety Personnel Retirement System for processing. Motion passed unanimously 4 to 0.

### 5. Review and discussion concerning the Policy 5-007, Pension Funding Policy.

• HB2097 requires that a PSPRS employer have a funding policy in place by July 1, 2019 and that it contain funding objectives that address the following: 1) how to maintain the stability of the governing body's contribution to the system, 2) how and when the governing body's funding requirements of the system will be met, 3) defining the governing body's funded ratio target under the system and the timeline for reaching the targeted funded ratio. The policy must also formally accept the employer's share of liabilities and then post the pension policy on our website.

A draft policy was prepared that meets the requirements. Laura and Chief Kahle reviewed software that might better define our funding stability, but did not feel the cost was warranted. PSPRS predicts our funding ratio to be fairly stable over the next 10 years at around 18.5%.

Please note that PSPRS can modify actuarial assumptions each year. Please also note that our pension is 84.7% funded and has an Unfunded Actuarial Accrued Liability (UAAL) of \$1,234,571. In 2015, we had a surplus of \$80,725. We could reach 97.4% funding level if we contribute an additional \$1,000,000.
