- B. Fire Chief's Report Reviewed by the Board. Report on file.
 - The person who gave us the notice of claim has withdrew. Our insurance company will keep the file active in the event he hires a new lawyer.
 - We are waiting for our new ambulance to be shipped. A recall is yet to be cleared.
 - We are still waiting for the Dodge ambulance to be repaired. A leak in the oil pan was discovered, repairs may be finished by the end of the month.
 - The final inspection for our new engine will be in July.
 - Fire Chief Tucker had the monthly meeting with L-5100. Chris Heady is the new President and Steve Rodriguez is the Vice President.
 - 71 new housing permits in May.
 - The District responded to 293 incidents and had 97 ambulance transports.
 - Included in the board's packet were photos of land in our response area that the City of Tucson intends to annex.
 - Question from Clerk McKinley on the effect on our District. Fire Chief Tucker stated that the intended annexation by the City of Tucson reduces our area by one square mile.
- C. April's Financial Reports Review, discussion and possible action, of the district's financial status including monthly summary reports for the month of May 2023. JVG presented May's financial report.

- Fiscal year revenue is \$6,771,034 which is over budget by \$177,433.
 - This does not include carryover funds or transfers.
- Fiscal year expense is \$5,503,214 which is under budget by \$1,141,386.
